EXPRESSED WARRANTY

OWNERS POLICY:

1. It is the owner's responsibility to ensure that anyone authorized to operate, lubricate, or maintain this unit is properly trained and qualified.
2. Your unit should receive periodic service inspection during the two (2) year warranty period to ensure proper operation.
3. Your MIGHTY AXE[®] distributor should be notified immediately of any potential problems or breakdowns that involve faulty material or workmanship. In the event of a warranty claim, the claim should be submitted to the company for processing.
4. MIGHTY AXE[®] backs up its warranty with parts availability and service engineers for assistance on special problems.
5. Regular maintenance will maintain the high efficiency built into your MIGHTY AXE[®] unit.
6. When repairs are needed, obtain genuine MIGHTY AXE[®] parts from the company. MIGHTY AXE[®] is familiar with your unit and is prepared to give you expert service to keep your unit at maximum operating efficiency.
7. Operation of your MIGHTY AXE[®] unit by a skillful operator will assure you of continuous satisfactory performance.

WARRANTY:

There are no warranties, expressed or implied, made by either the distributor or the manufacturer on new MIGHTY AXE, INC. equipment, except the manufacturer's warranty against defect, material and workmanship set out below:

NEW EQUIPMENT WARRANTY: The manufacturer warrants each new product made by the manufacturer to be free from defects in material and workmanship, its obligation and liability under this warranty being limited to replacing free of charge at its factory, any parts proving defective under normal use and service within two (2) years from the date of initial sale. This warranty is in lieu of all other warranties, expressed or implied and the obligation and liability of the manufacturer under this warranty shall not include any transportation or other charges or the cost of installation or any liability for direct, indirect or consequential damages or delay resulting from the defect. Any operation beyond rated capacity or the improper use or application of the product or the substitution upon it of parts not approved by the manufacturer shall void this warranty. This warranty covers only the products of MIGHTY AXE, INC. The products of other manufacturers are covered only by such warranties as are made by their manufacturers. Hydraulic Hoses and Blades are not included under this warranty. This warranty is expressly in lieu of any other warranties, expressed or implied, including any implied warranty of merchantability or fitness for a particular purpose, and of any other obligations or liability on the part of the manufacturer, and MIGHTY AXE, INC. neither assumes nor authorizes any other person to assume for it any other liability in connection with such equipment.
